Dear Sir/Madam

Kindly accepts my apology for sending unsolicited letter to you. I believe you are a highly respected personality in your country. Though, I do not know to what extent you are familiar with events. I would respectfully request that you keep the contents of this letter confidential and respect the integrity of the information you come by as a result of this. I contact you independently and no one is informed of this communication.

My names are Alexander Selepe, I work with a private Security Company here South Africa, I have worked for more than 17 years now. Actually, I got your contact information through the South Africa Chamber of Commerce records while searching for a last name similar to my late client, who worked as a contractor here in South Africa for over a decade prior to his death, He came to our company to engage in business discussions / investment of his Estate Lodgment ..

The reason I have contacted you is because you have the same last name as the deceased as this makes it easier to say you are the next of kin to the client. In my search for possible relatives, I came across your contact information. You are not really related to the deceased, you only just happened to have the same last name. He is a wealthy civil engineer who worked as a contractor with Anglo American Platinum (SOUTH AFRICA) and in several countries like South Africa, Brazil, Saudi Arabia, India, and mostly in Dubai.
